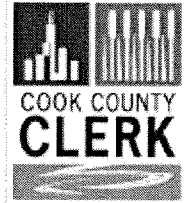

PALATINE PARK DISTRICT  
 AN ORDINANCE LEVYING AND ASSESSING THE TAXES OF  
 THE PALATINE PARK DISTRICT FOR THE 2015 TAX YEAR  
 ORDINANCE #15-12

BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF THE PALATINE PARK DISTRICT, COOK COUNTY, ILLINOIS AS FOLLOWS:

SECTION 1: The sum of Twelve Million three hundred eighty-eight thousand three hundred and eight dollars (\$12,388,308) or so much as may be authorized by law, be and hereby is assessed and levied for the anticipated objects and purposes specified against all taxable property within the limits of the PALATINE PARK DISTRICT at full, fair cash value as the same is assessed and equalized for State and county purposes, for the 2015 tax year.

SECTION 2: Pursuant to 70 ILCS 1205, Sec 4-4, neither the Budget and Appropriations Ordinance of District for the fiscal year beginning January 1, 2015 and ending December 31, 2015 nor any other budget and appropriation ordinance is intended or required to be in support of the tax levy made in this ordinance.

SECTION 3: Hereinafter set forth under the column entitled "Amount to be Raised by Tax Levy" is the specific amount hereby levied for each object and purpose.

SECTION 5: This ordinance shall be in full force and effect from and after its passage and approval as required by law.







**ANNUAL ABATEMENT ORDINANCE**

**ORDINANCE #15-13**

ORDINANCE abating the tax hereto levied for the year 2015 to pay the principal of and interest on General Obligation Bonds (Alternate Revenue Source), Series 2008A, and General Obligation Park Bonds (Alternate Revenue Source), Series 2011A, of the Palatine Park District, Cook County, Illinois.

WHEREAS the Board of Park Commissioners (the "*Board*") of the Palatine Park District, Cook County, Illinois (the "*District*"), by Ordinance Number 08-08, adopted on the 7th day of October, 2008, and Ordinance Number 11-07, adopted on the 28th day of June, 2011 (together, the "*Ordinance*"), did provide for the issue of \$7,000,000 General Obligation Bonds (Alternate Revenue Source), Series 2008A, and \$3,000,000 General Obligation Park Bonds (Alternate Revenue Source), Series 2011A (together, the "*Bonds*"), and the levy of a direct annual tax sufficient to pay the principal of and interest on the Bonds; and

WHEREAS the District hereby determines that the Pledged Revenues (as defined in the Ordinance) are available to pay the principal of and interest on the Bonds when due so as to enable the abatement of the Pledged Taxes (as defined in the Ordinance) levied for the same; and

WHEREAS the Pledged Revenues in an amount not less than the debt service requirement on the Bonds for the next succeeding bond year are hereby directed to be deposited to the Bond Fund (as defined in the Ordinance) and used for the purpose of paying the principal of and interest on the Bonds due in the next succeeding bond year; and

WHEREAS it is necessary and in the best interests of the District that the tax heretofore levied for the year 2015 to pay the principal of and interest on the Bonds be abated;

NOW THEREFORE Be It Ordained by the Board of Park Commissioners of the Palatine Park District, Cook County, Illinois, as follows:

The President announced that the Board of Park Commissioners would consider the adoption of an ordinance abating the tax levied for the year 2015 to pay the principal of and interest on the District's outstanding alternate bonds.

Whereupon Park Commissioner Rogers presented and the Secretary read by title an ordinance as follows, a copy of which was provided to each Park Commissioner prior to said meeting and to everyone in attendance at said meeting who requested a copy:

*Section 1. Incorporation of Preambles.* The Board hereby finds that all of the recitals contained in the preambles to this Ordinance are full, true and correct and does incorporate them into this Ordinance by this reference.

*Section 2. Abatement of Tax.* The tax heretofore levied for the year 2015 in each Ordinance is hereby abated in its entirety.

*Section 3. Filing of Ordinance.* Forthwith upon the adoption of this Ordinance, the Secretary of the Board shall file a certified copy hereof with the County Clerk of The County of Cook, Illinois, and it shall be the duty of said County Clerk to abate said tax levied for the year 2015 in accordance with the provisions hereof.

*Section 4. Effective Date.* All ordinances, resolutions or parts thereof in conflict herewith be and the same are hereby repealed and that this Ordinance shall be in full force and effect forthwith upon its adoption.


