REGISTRATION NOTES

- Children must attend school at the C.A.R.E. location they are applying to in order to be eligible to register for or attend the C.A.R.E. Program at that school. We are not able to accept transfers to a C.A.R.E. location if the student attends school at a different location in the district during the day.
- Annual fees are based on the number of C.A.R.E. attendance days. C.A.R.E. is not offered on days when school is not in session.
- After-School C.A.R.E. is not offered on half-days of school.
- Tuition is divided into 10 equal installments. Payments are automatically withdrawn August 1 May 1.
- Fees are subject to change if school start and end times change.
- 2nd child discount is applied to the lowest priced option.
- \$60 non-refundable registration fee is due with each enrollment application.

PLEASE NOTE: All <u>drops and schedule changes</u> MUST be submitted in writing by July 25, 2024 in order to take effect at the beginning of the 2024/2025 school year. Any changes made after July 25 will be billed for the August 1 installment and any drops or changes will not take effect until the September billing installment.
