Visitors and Citizens' Comments

Commissioner Ruff advised Mr. Skorski that he has three minutes to speak.

Frank Skorski: It doesn't matter, I'm talking to the wall, but I just wanted to come here and congratulate Ben and Jen on their anniversary of the first time that, to my knowledge, the Palatine Park District violated the law, and you just made an oath of office. Commissioner Ruff reminded Mr. Skorski that his comments should be kept to Park District business, not accusations. Ben and Jennifer came up with \$2.6 million, that was a highly inflated democratic estimate of the repair cost. Executive Director Report

Director Rea reported that the Big Truck event was this past Saturday, with over 3,000 people in attendance and thanked the team for a successful event. He also shared that the Mari-Rae Sopper Gymnastics Show which is this Friday and Saturday at the Community Center.

Commissioner Reports/Future Agenda Items

Commissioner Gould shared that she was at the Big Trucks event, and they ran out of giveaways about an hour before the event ended. She said it was fun, everybody seemed to have a great time, and the weather cooperated. In response to Commissioner Rogers' question, she said that over 250 people stopped by her table to enter the raffle for a fire truck she was giving away. Commissioner Gould also shared that it was interesting to see where people come from; she has some from Chicago, Gurnee and Naperville. She said it was a great event, everything was perfect and complimented the staff.

Commissioner Petricca said there seems to be some issue with electric bikes on the bike path and asked if we have a policy on that? Director Rea explained that they are almost unenforceable from a Police Standpoint because they have pedals, so they are not considered motorized vehicles. We have in place a max speed limit but, the enforcement side of things is very difficult. He suggested that we talk to our legislators about putting some other rules in place as it's an ongoing issue, and not just here at the Palatine Park District but across the state. Commissioner Gould agreed and said that she is going to speak with Brad Helms, her council person, due to the issues she's seeing; it has gotten to be like kamikaze corner by her house. She also shared the parking issues on her street. She has tried to talk to Village Manager Ottesen in the past, but he told her to have the park district put up signs. She feels that we need to figure out something. Commissioner Petricca explained that he has had people reporting the issues to him and asked if we could put up signs with the rules. Discussion continued with regards to Hamilton, the trail and the parking issues with all the sports and other activities going on at Hamilton. Commissioner Rogers mentioned the Senate Bill that amended the definition of a bicycle; Director Rea said there needs to be more work on setting restrictions. Commissioner Gould brought up the issue with the kids riding golf carts on the bike path; they didn't seem to understand what a motorized vehicle is. She understands the beauty of an electric bike but feels that we need to have some classification of what kind of vehicles can be on the bike trails.

Commissioner Sammons wanted to thank everyone for the opportunity to go to the Legislative Conference. He finds it enjoyable and where he learned about the Senate bill and the new definition of a bicycle, he shared the details of the Bill. Discussion ensued about the bill, the use of e-bikes on a bike path, and getting the Village involved. Director Rea said that he will talk to Manager Ottesen about this.

Commissioner Ruff attended the POC Fundraiser; it was a really nice event at the NOW arena.
